- 8. Amendments to MBL Bylaws
 - -Absences at events:
 - -Adoption of existing NESSA policy
 - -Unannounced absence is punishable by probation for that team
 - -A team may cancel their participation in the event up to 48 hours prior
- 9. Update on NESSA and ISSA
 - -Relationships with NESSA and ISSA discussed
 - -Differences with ISSA addressed:
 - 1. School Sanctioning
 - -Philosophical differences
 - -Liability technicalities
 - 2. ISSA Board to be improved
 - 3. Allocation of berths to National Championships
 - -Baker is affected, for example
 - 4. Financial Model should be reviewed, improved
 - -Imbalance in contribution of funding should be addressed
 - 5. Move fleet race championship (Mallory) to a later date in the season
 - -Qualifier for Mallory should not occur over public schools' spring break
 - -Insufficient record of results for the spring season used to determine participants
 - -Motion presented: MBL financial contribution to ISSA should be used as leverage to make above changes
 - -If no changes are made, MBL must be willing to walk away from ISSA.
 - -Question posed: Does MBL have any coverage under ISSA?
 - -Answer to be researched
 - -Fall 2012: MBL members should plan to attend meeting, so that above interests can be addressed
 - -General interest to inform Athletic Directors at MBL schools about above interests
 - -MIAA rules to be considered, as many schools within the MBL follow MIAA rules with respect to sailing, as well (although sailing is not a MIAA sport)
 - -specifically, with respect to insurance policies
 - -Observation noted that private prep schools are more involved in national competition, therefore more hesitant to separate from ISSA
 - -Motion presented: segregation within MBL membership
 - -NESSA membership only
 - -or ISSA membership additionally (National Championship qualified)
 - -All above to be determined by vote at meeting in Fall 2012
 - -Observation that location and time greatly affect attendance at meeting
 - -Interest in consistently changing location to improve attendance
 - -As determined by vote, MBL generally finds ISSA involvement not a priority
