Relationship with CBI - CBI is restructuring their scholastic sailing program to reduce the number of schools and the number of sailors. As a consequence, they are severing their 35-year relationship with the MBL. Per our Deed of Gift, CBI owes the MBL half the appraised value of the 420s that we helped to purchase and we expect that it will be paid over the coming year. Furthermore, CBI is requiring that we pay a fee of \$5 per sailor per day to hold regattas there.

Update on NESSA and ISSA

NESSA meeting was attended by Carl, Gary (Sharon), Jeff (BB&N), Elliot (Dover-Sherborn), Chris (Duxbury), Kevin (Manchester-Essex), and Bill (St. John's Prep). Proposals were made to move the O'Day to the end of the season, to expand the Mark to more teams on a single weekend, modification of the Women's Invitational to become a championship event, and to create a NESSA-only for teams uninterested in national championships and composite teams. None of these changes were adopted.

Another meeting will be held on Saturday, February 2 at Tabor. Coaches were encouraged to attend, and to confirm their voting eligibility before the meeting.

2. Consideration of New Members

Scituate High School was welcomed to the B Division, and will be sailing in Scituate Harbor. Easton was represented at the meeting, and currently is interested in gathering all necessary information to begin forming a sailing team. No motion was made to join the League at this time.

Discussion of MBL Championship Regatta - venue, fees, format

CBI is requiring that we pay a fee of \$5 per sailor per day to hold events at their venue. For the MBL Championship, this means it will cost us \$800-1000 per day to rent the facility. Discussions with MIT are being entertained, with no commitments made at this time.

Proposed structure for events hosted by Sharon includes:

- -Visiting schools may have 3 -4 boats in a 16 boat fleet.
- -Rotations will not be incorporated, with the interest of maximizing sailing time for all students.
- -Events are made available to all divisions, and provide an opportunity for less experienced sailors to gain fleet racing exposure.

Proposed structure for events hosted by Courageous includes:

-Rhodes 19 fleet racing will be made available to all MBL divisions, if enough interest is demonstrated. Fridays in early April were suggested as potential race days. Boats can accommodate 2-4 sailors depending on skill and conditions.

JV, Undergrad and Women's regattas are cancelled due to CBI restrictions, and will be revisited next year. These regattas may be possible if an alternative venue becomes available, and that school offers to host.

Race scheduling for teams at CBI will be determined by the C Division and CBI, per their individual discussions as independent schools and as a Division. A meeting with all parties is scheduled for February 5.

#### Other New Business:

Moses Brown is selling 7 FJs for \$7,350. A proposal was made for the League to purchase the matched fleet, to be made available to schools looking for a fleet once a venue is obtained. It was also proposed that the boats could be chartered to teams on a temporary basis. Storage for boats would be provided by Moses Brown until May 2013. Boating in Boston at UMass Boston has long term storage potential. If no school in the League has purchased the boats from the League by that point, the fleet would be put up for sale. A motion for the Board to research logistics further, with intent to purchase the fleet, was passed.
