## Procedural rules issues

Items approved at October meeting should be formally changed in the By-Laws and Procedural rules: All changes below were approved by unanimous consent.

1. Approval for annual dues to be approved at October/November meeting instead of January.
Change By-Laws Article IV, Section 2
Section 2: MEETINGS OF MEMBERS: There shall be at least three meetings of the League during the scholastic calendar year, including the Annual Meeting. The Annual Meeting of the League shall be held during the month of January each year. Business transacted during the Annual Meeting shall include the consideration of new members, approval of annual League dues and fees, and submission of scheduling requests. Other meetings may be held by consensus of the officers, or upon petition by at least three Active Members to the executive committee. The executive committee will determine the time and place of the all meetings.

Change By-Laws Article V, Section 1

Section 1: DETERMINATION OF LEAGUE DUES: The sum of the dues is to be recommended by the Executive Committee and approved by the Active Members at the Anmual Meeting Fall meeting. Additional dues may be levied as necessary with the approval of the Active Members. The sum of dues may differ for different categories of Membership. The monies derived from dues shall be used to support League activities that benefit all Members of the League.
2. Removal of the requirement for B Division teams to sail outside their division. Change Procedural Rules - Delete Rule 9, b, iv.
iv. Each team must race at least two (2) team races against teams outside their division. One may be against a team from another B Division and the other (or both) must be against NESSA teams that are not members of MBL or MBL teams in the A Division. If any team does not satisfy this requirement, each meet not sailed shall count as a loss for the purpose of divisional standings.
3. Change the competition scheme to accommodate two A subdivisions Change Procedural Rules - Amend Rule 9, a, iii.
iii. Each team in the division must sail a team racing meet against every other team in the division their subdivision, and against two or three teams in the other subdivision as prescribed in the league default schedule. The default schedule will use the previous year's standings to determine a scheme that matches teams of similar quality. Any such meet that is not sailed or forfeited before the end of the regular season shall be scored as a loss for both schools involved.
